Educational & Vocational Programs - Farm of the Child supports the academic and vocational education of 120+ students through the St. Peter's Catholic School and the Vincent Prescatore Institute at Finca del Nino in Trujilio Colon, Honduras. Additionally, Farm of the Child supports their secondary education through local high school programs. Farm of the Child offers scholarship opportunities for qualified youth to pursue university education, both within Honduras as well as internationally, when possible.  
Farm Operations - Farm of the Child supports the programmatic administration of Finca del Nino in Trujilio Colon, Honduras through the support of an Program Administrator, a Program Director on-site in Honduras, as well as all administrative expenses for program operations in Honduras.
